### **SALE OF SHARES BY A CONTROLLING SHAREHOLDER OF THE COMPANY**

This announcement is made by Kwan On Holdings Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company has been informed by Variety Rich Limited (“**Variety Rich**”), a controlling shareholder (as defined in the Listing Rules) of the Company, that on 28 September 2016, Variety Rich has sold 79,000,000 shares of HK\$0.01 each in the issued share capital of the Company (the “**Sale Shares**”) at the consideration of HK\$0.83 per share (the “**Sale**”) to certain purchasers who are independent third parties of the Company and its connected persons (as defined in the Listing Rules). The Sale Shares represent approximately 8.23% of the issued share capital of the Company as at the date of this announcement.

As at the date of this announcement, Variety Rich is owned as to 87.5% by Mr. Wong Yee Tung, Tony (“**Mr. Tony Wong**”), the Managing Director of the Company and 12.5% by Mr. Kwong Wing Kie (“**Mr. Kwong**”), the Executive Director of the Company.

Immediately following the Sale, Variety Rich holds 151,375,000 shares in the Company, representing approximately 15.77% of the issued share capital of the Company as at the date of this announcement, and Mr. Tony Wong, Mr. Kwong and Variety Rich remain as controlling shareholders (as defined in the Listing Rules) of the Company.
